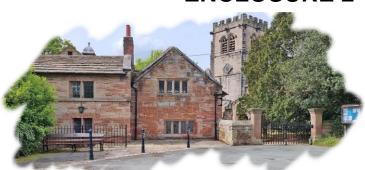

Dear Judith

Nether Alderley Parish Hall's Grade II\* Renovation has Approved Section 106 payments to the Value of £163,727.70. This related to planning application ref 15/5401M

I have been trying for some months to have access to the approved s106 funds, originally hoping for CEC to pay our contractors up to the value of the s106 and reclaim the VAT. However, significant delays in securing a response from CEC has resulted in the need for the Parish Council to pay the contractor's first three monthly valuations and recover the VAT. We have become VAT registered but for a small Parish Council we are trying to avoid the additional cash flow problems of paying and recovering VAT on the s106 contribution.

I very much hope that for subsequent valuations we can use your process of registering our contractor with you and they can be paid directly up to the remaining s106 following the submission of the valuation certificates from our Architect and Quantity Surveyor.

### In the meantime we need s106 funding from CEC to cover the cost of the first three contract payments

I enclose the three valuation certificates with their Interim payments and evidence of those payments being made from our Scribe Accounting Software. I also attach reports from STMS Building Control and a report from B & E Boys, our contractor. The project is on cost and timetable and a graph of the payment profile excluding VAT is also attached.

The value of the contract is £619k including £72k of contingency and PC sums which have not been called upon to date and we are monitoring these very carefully. We have assembled funding including CIL, grants and PWLB loans to fund this project but we need to have access to the s106 now.

The three valuations (attached) amount to Valuation1 May £6,992.78 exclusive of VAT Valuation 2 June £9,896.18 exclusive of VAT Valuation 3 July £47,603.82 exclusive of VAT Total £64,492.78 exclusive of VAT and this is the amount we currently are

requesting from the s106

I do hope you can respond to this request urgently

I think their hall is a little larger than ours but obviously not as picturesque or well presented and equipped as ours will be. They have a range of prices including for weddings. The total hall is available for from 3pm Friday to noon on Sunday for wedding receptions at £1700 which certainly agrees with the price Marcus was suggesting when we met.

They do have a bar and clients are expected to pay the staff wages. If clients are providing their own drinks then corkage is charged.

I'll bring the full details to the meeting.

I've also spoken to PrintIt with regard to a logo and also revamping the Newsletter. With regard to the blinds I have several estimates but the general advice is that Roman blinds would not be practical due to the amount of use they would receive and the height at which they would be fitted so I have prices for curtains as well.
